Syllabus:

In three days workshop we will cover Risk Management - a tool for loss prevention and Loss Control Measures, Marketing Techniques, Insurance Market in India and future Challenges, Customer Service, Regulation of Corporate Agents and Legal Boundaries etc.

Course Fees:

- a) Participants requiring **residential facilities:** Rs. 7800 /- Plus service tax of 10.3% (Total Rs.8603/-)

The fees include tuition, course material, A/C single room accommodation in the Institute's campus and full boarding (bedtea/coffee, breakfast, lunch, light refreshments in the evening and dinner). All rooms are fully furnished with attached bathroom and Internet facility.

Rooms are reserved from the day prior to the commencement of the programme. The participants can stay for a day after the conclusion of the programme.
