5. PRE - LICENSING TEST FOR INSURANCE SURVEYORS & LOSS ASSESSORS

1. The Insurance Regulatory and Development Authority has authorized the Institute to conduct a Pre-licensing test for Insurance Surveyors & Loss Assessors, as required by the regulations.

2. To check eligibility/qualification criteria, kindly visit IRDAI's website. www.irda.gov.in

3. Detailed information regarding syllabus, enrollment, examination fees, dates, etc., is posted on the Institute's website <u>www.insuranceinstituteofindia.com</u> as well as on the IRDAI's website <u>www.irda.gov.in</u>

4. This examination will be conducted in online mode with MCQ pattern i.e. four times in a year i.e. March/June/September/December and the passing percentage is 60% (i.e. 60 marks out of 100 marks).

5. Persons enrolled with the IRDAI as trainee surveyors, (As per guidelines received from IRDAI Circular Ref: IRDA/SUR/GDL/MISC/288/12/2020 Dt. 01.12.2021. are eligible to appear in the Pre-licensing test for Insurance Surveyors and Loss Assessors) Candidates can register, enroll & book the slot/subject and make the payment for Surveyor Examination/ Papers through the online option available on I.I.I. website. (The candidates who have already registered for Surveyors Exam need **NOT** register again and can continue with their registered registration number only). Please refer Calendar of Important Dates for the Online Examination Schedule and for the registration process refer **HELP MANUAL (Examination – Help Manual – Help Manual Surveyors)** available on the website. The registration fee for fresh candidates (one time) is Rs.500/- and the exam fee is Rs.500/- per subject plus service tax which is applicable.
