Rules & Regulations

- 1. The Competition is open to the office bearers of Associated Institutes of the Insurance Institute of India.
- 2. No age restrictions.
- 3. Essay will be accepted from individual members only. Joint contributions will not be accepted.
- 4. Essay submitted for consideration should not be previously published or presented elsewhere.
- 5. The contribution should be original. Participant should make a declaration to that effect while submitting the essay.
- 6. The Essays must be sent through e-mail on competition@iii.org.in and should reach on or before 29th January, 2022 which is extended by our competent authority.

7. Prize Scheme:

8. Word Count limit of Essay:

Maximum – 5,000 words & Minimum – 3,000 words plus an Abstract of not more than 500 words.

The contribution should be submitted in word format (.doc file) with the following settings:

- a) Font Name "Times New Roman"
- b) Font Size 12
- c) Space between lines 1.5
- d) Space before paragraph 6 pt.
- 9. The essay should be original, well researched and all sources should be duly acknowledged. A bibliography, a list of references and footnotes, if any, should be attached at the end of essay. This will not add to the final word count of the Essay. The participants should avoid using overbearing words and sentences. Participants should ensure that the essay ideas are well expressed and in neat manner.
- 10. Participants should ensure that their Essay is free from plagiarism. Essays which are found plagiarized will be disqualified from the competition.

- 11. The contribution should be submitted in the following format:
 - Covering Letter containing participation and self-declaration regarding originality of the Essay.
 - Main Essay in word format i.e. .doc file only (do not mention author details in this file)
 - The below details of Participant / Author in excel format i.e. .xl file is mandatory to be submitted (such as Participant / Author name, Residential & Office address, Registration Id. Candidate Id., Date of Birth, Qualification etc. should be mentioned).
