Insurance Institute of India (III) and National Institute of Disaster Management (NIDM) are jointly organizing a series of monthly webinars known as ***“Disaster Risk Financing & Insurance: Disaster and Insurance Awareness - Monthly Online Webinar (DIA-MOW)”***. The webinar series is aimed at making the country aware of disaster risks and how these can be transferred to the insurance mechanism in a cost effective manner. The importance of Disaster Risk Financing, the governmental vision on Disaster Risk Financing and the recommendations of 15th Finance Commission regarding Disaster Risk Management are discussed. DIA-MOW gives multiple stakeholders an understanding of how the insurance mechanism works and how the insurance industry is kept solvent through global regulatory frameworks and prudential practices. The first webinar of the series was held on September 24th, 2021.

The second ***“Disaster and Insurance Awareness - Monthly Online Webinar”***, was conducted on October 22nd, 2021. This time the focus was mainly on the North Eastern States viz. Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim and Tripura.

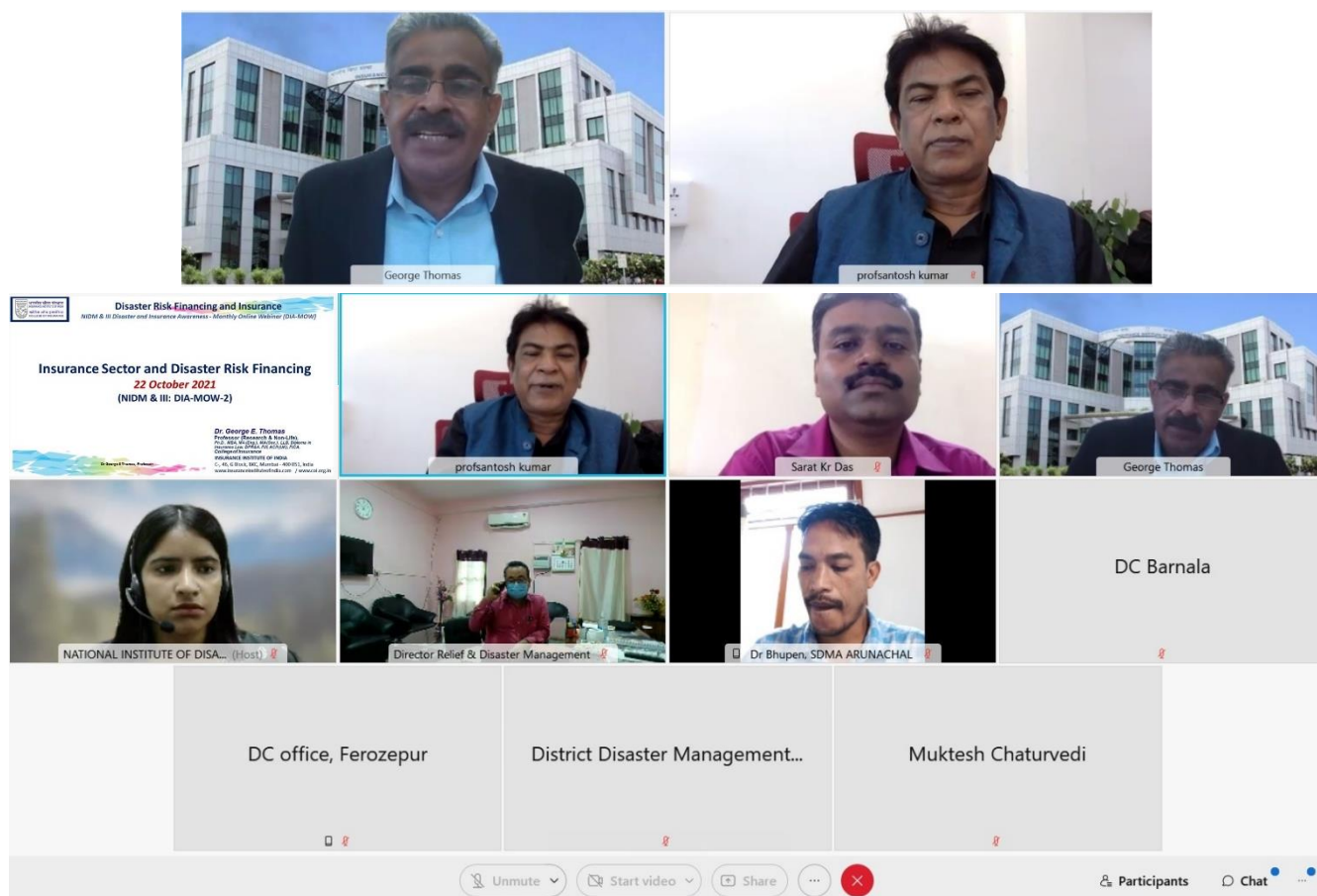
DIA-MOW series is conducted under the patronage of Maj. General Manoj Kumar Bindal, ED, NIDM and Mr. Deepak Godbole, Secretary General, III with Prof. Santosh Kumar, Head, GiDRR, NIDM and Dr. George E. Thomas, Professor, COI, III as speakers.

Ms. Shipra Das Young Professional, NIDM welcomed all the participants for the 2nd session and explained the webinar format. During his Key Note Address, Prof. Santosh Kumar spoke about the importance of Disaster Risk Financing, the Governmental Vision on DRF and the recommendations of the 15th Finance Commission. The theme speaker, Dr. George E. Thomas explained how the insurance sector does the financing of Disaster Risk and how insurance can play an important role when it comes to building financial resilience. He explained and how the insurance industry is regulated in India and globally for protecting Policyholder's interests. He also gave an overview of some insurance products. Mr. Sarat Kr. Das, State Project Officer, Disaster Management, Tripura spoke about the disaster risk management and insurance experiences they recently had in the State of Tripura. Representatives of other States also voiced their opinions.

The webinar was attended by Officials from multiple State Disaster Management Authorities and participants representing multiple industries.

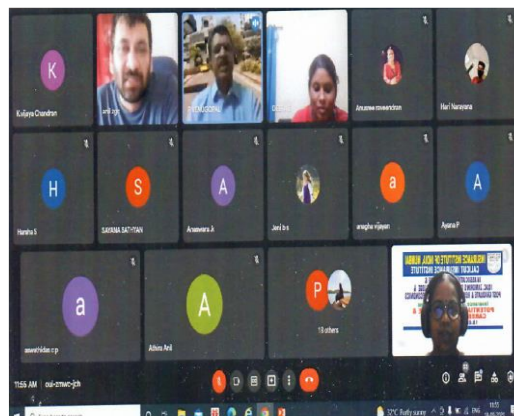
Calicut Insurance Institute has organized an Insurance Awareness Program through virtual mode on 18th September 2021.

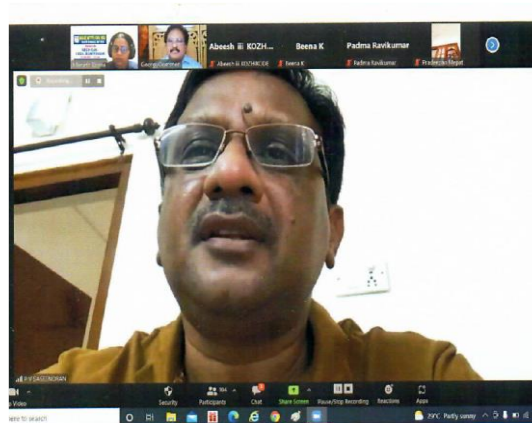
Calicut Insurance Institute has conducted a local seminar on the topic of “Pension Plans – A Social Security Measure” on 21.09.2021 through virtual mode.
