CC4 - Certification Course in Investigation and Fraud Detection in Life Insurance

According to Deloitte's Insurance Fraud Survey 2023, the Indian insurance sector has witnessed a substantial surge in fraudulent activities within the life and health insurance domains. Around 60% of respondents noted a significant increase in fraud. The fraud in life insurance has grown post Covid 19 and living in denial mode is not going to help anymore. Prioritizing the fight against fraud with investments in useful resources including those of digital predictive analytics is gaining prominence. Professional and effective investigation to detect fraud and collecting legally acceptable evidence and well written Investigation Reports which stand with credibility in Courts of Law is an important tool in the fight against fraud in life insurance. Hence the need for qualified, trained and competent professional investigators to curb fraud. Life Insurers need to build internal cadres of employees who are competent to do fraud related investigations in a professional manner, and support attempts to fight fraud. This would help in making the industry more resistant to fraud, thereby protecting honest policyholders' interests as well as corporate interests. It would also provide better academic and professional credibility to the employees who need to represent and testify the Company in Courts of Law, and other judicial/ public forums.

With the above background in mind, this Certification course has been designed for Life Insurance professionals working in the field of Insurance Investigation / Fraud Cells/ Claims Departments/ Audit functions of the Company, and others who have a good understanding of Life Insurance and a flair for investigation. The course would help internal Investigators to detect and report on Frauds with tangible evidence thereby arrest the growing frauds in the Industry.
