#### PROGRAM CONCEPT AND OBJECTIVES:

The insurance industry, including insurers, Third Party Administrators (TPAs), brokers, Health care providers, and researchers, increasingly relies on healthcare data to enhance their offerings. Data analytics is critical in designing products, pricing, marketing, underwriting, and claims management. A crucial element of effective data analytics is the standardization of medical information through globally recognized coding systems like the International Classification of Diseases (ICD) and the Procedural Coding System (ICD-PCS).

The transition to **ICD-11**, effective from January 1, 2022, represents a significant advancement in healthcare standardization. It offers detailed classifications for diseases, disorders, injuries, and causes of death, as well as pharmaceutical and topographical coding. These coding systems are instrumental in improving accuracy and efficiency in claims processing, healthcare delivery, and insurance product development.

To address the growing demand for expertise in ICD coding and disease classification, the **College of Insurance** has designed a two-day training program. This program focuses on ICD appreciation, coding standards, and disease classification while providing foundational knowledge of human anatomy and medical conditions for participants with limited exposure to medical or paramedical knowledge.

### **KEY TAKEAWAYS FROM THE PROGRAM:**

- Providing the participants a basic understanding of human anatomy
- Understanding diseases and disease types, basic medical interventions and diagnostics
- Revisiting the health insurance practices and basic analysis based on granular data
