Program Concept and Objectives:

Though Motor Third Party insurance contributes sizably to the premium of Insurance companies, the claim outgo of this line of business has been always a matter of concern to the industry. Many factors like benevolent legislation, unlimited liability, situations of lack of evidence and witnesses, organized and opportunistic fraud etc. allow only limited defense for the insurers in dealing with TP matters effectively, contributing to the claims ratio. Managing this portfolio has always been a challenge to the insurance companies. Inefficiencies in handling settlements through MACT, Lok Adalat and other grievance redressal procedures also take their toll in terms of time and cost. However, certain provisions of the MV Act, its amendments from time to time, punitive legislations and efforts at managing road traffic risk have paved the way for controlling road accidents and helped in the better management of TP Claims in the times to come.

The program of two days duration has been designed to impart knowledge in the relevant areas on managing Motor TP Claims, controlling Fraud and generating revenue for the Insurers.
