As the world is becoming smaller with technological advancements and the country working closer with the global community, Regulatory Compliances, Risk Management and Governance in the financial sector have become more challenging. The Indian Insurance Market and the Regulators of the Financial Sector are increasingly becoming conscious of the changes happening worldwide and taking due care so that the Indian industry learns from the best practices around the globe.

Insurance professionals, like their counterparts in the financial sector, have to keep abreast of the changing regulatory requirements. Those involved in governance and

compliance functions have to be cognizant of this as part of their job. However, professionals dealing with compliance need to appreciate the philosophy behind the regulations, widen their awareness of international trends and develop perspectives to ensure proper application of their knowledge to local realities so that they can perform efficiently and ensure that the spirit of the regulations is not lost under the monotonous and routine nature of mandatory compliances.

The Course is designed to create a cadre of professionals well-versed in risk management, governance and regulatory compliances in the field of Insurance regulation from among the Associates/ Fellows of III and ICSI.
