Program Concept and Objectives:

The Healthcare sector is becoming increasingly challenging day by day. Medical diagnosis and treatment have become increasingly complex. Consequently, today's insurers need to increase their knowledge and improve their technological skills to be competitive. They need to understand the changes in the market by analysing data relating to many diseases, treatment protocols and the costs involved. For such deep and detailed analysis, they need to understand standardized medical terms, precise coding, and data at granular levels.

Efforts towards standardization are ongoing worldwide over many years. Classification of medical data is essentially the transformation of verbal descriptions of medical diagnoses and procedures into universally acceptable code numbers. The most widely used coding protocol specific to healthcare is the International Classification of Diseases (ICD) which relates mainly to (i) **Diagnostic codes** used for diseases, disorders and symptoms and facilitate measurement of morbidity and mortality, (ii) **Procedure codes** used to identify specific health interventions taken by medical professionals, (iii) **Pharmaceutical codes** used to identify medications and (iv) **Topographical codes** that indicate a specific location in the body. Coding Health Insurance related data using ICD codes helps in identifying the frequency of diseases within specific geographies, age groups, occupations, behavior groups and other sub-strata of the market. These codes, especially, the Diagnostic and Procedure codes are widely used by the insurance industry to analyse diseases, medical procedures and interventions. The coding is typically done usually using health management software at clinics, hospitals and Third Party Administrators (TPAs).

College of Insurance has designed this program to focus on the Classification of Diseases and Coding. While the programme is open to both medical and non-medical professionals, on order to make it meaningful to those who are not exposed to medical/ paramedical knowledge, there will be an introductory session on human anatomy, disease types and basic medical matters.
