## Virtual Training Session on Anti-Money Laundering (AML), KYC and Counter-Financing of Terrorism(CFT) - Program ID – CPL21 (Date – 20<sup>th</sup> June 2023)

Money Laundering is moving illegally acquired cash through financial systems so that it appears to be legally acquired. There are three common stages i.e., Placement, layering and integration of money laundering. Through this method the illegal proceeds back into the economy in such a way that they reenter the financial system appearing to be normal business funds. Insurers more specifically Life insurers which may unwittingly get exposed to a potential criminal activity while undertaking normal business transactions. The IRDAI has issued Circulars from time to time for prevention of money



laundering and CFT in Insurance Industry. Financial institutions such as Insurers are therefore placed with a statutory duty to make a disclosure to the authorized officer when knowing or suspecting that any property directly representing the proceeds of a predicated offence, or was or is intended to be used in that connection is passing through the Life insurer. The KYC, Enhanced Due Diligence (EDD), Reporting of Suspicious transactions, training the employees and intermediaries, etc., are the key elements. To comply with these guidelines every Insurer should have an AML/CFT program to discharge the statutory responsibility.

**Program Objective:** The program is designed to deal with the various guidelines issued by the IRDAI analytically to give an understanding about AML and CFT for compliance.
