# Virtual Training Session on Prevention of Sexual Harassment of Women (POSH) (CVT) on 21<sup>st</sup> August, 2025

## **Program Concept and Objectives:**

With an emphasis on gender diversity in workplace, there is an exponential growth in the no. of women joining the work force. To provide a safe and gender neutral work environment it has become important to create a conducive atmosphere. Keeping this in view The Sexual Harassment of Women at Workplace (Prevention, Prohibition, and Redressal) Act, 2013 was enacted. Sexual harassment isn't only limited to its most obvious form such as making inappropriate advances. It can also include unwelcome verbal or physical behaviour that creates a hostile work environment. Also, it is not limited to the office space only, but can go beyond within the work environment.

PoSH training will guide to differentiate between appropriate and inappropriate workplace behaviour and educate you on the definition & consequences under the PoSH Act. It talks about the different ways in which someone can be sexually harassed and how they can complain about this kind of behaviour.

COI has created 'Virtual Training (CVT) Rooms' to conduct the above program as a cost-effective mechanism for participants to equip themselves academically at their respective locations.
