Relevance of the Program:-

Livestock Sector is an important sector of national, especially rural economy. The supplemental income derived from rearing of livestock is a great source of support to the farmers facing uncertainties of crop production, apart from providing sustenance to poor and landless farmers.

Livestock is one of the most important productive assets in the rural areas in India and livestock insurance is an effective mechanism for the farmers to cope with household related shocks.

Over the period several livestock insurance mechanisms have evolved and became operational to face the challenges of bringing livestock assets of the resource poor under comprehensive risk cover.

The Ministry of Dairy and Animal Husbandry of the GOI has increased the scope of Animal and Livestock insurance manifold. To make the benefits of insurance reach rural India in a cost effective manner, technology is to be employed in a big way. However, challenges do emanate from a lack of understanding of the basics of Cattle Insurance and using technology effectively.

College of Insurance (COI) has designed this course to help professionals involved in Livestock and Cattle Insurance understand the concepts of different Livestock Insurances better and enable them to use technology more effectively to connect with the rural population.
