

## **Pre-Licensing Final Practical Test**

### **For Fresh Surveyors and Existing Surveyors for the Additional Dept.**

The Insurance Institute of India is announcing the **pre-licensing final practical test** for Fresh surveyors and Existing surveyors for the Additional Department. The Final Practical Examination is proposed **on 04<sup>th</sup> February 2026 and 05<sup>th</sup> February 2026 on the Microsoft Teams platform.**

#### **Eligibility criteria for the Final Practical test**

1. Enrolment with IRDAI for the department should not be **older than 3 years.**
2. Candidate should have passed mandatory **S-01 (Principles and Practice of Insurance and Survey and Loss Assessment)** and at **his respective subject** exam conducted by III **before commencement** of the practical training with senior surveyor **for the respective subject.**
3. Practical training with a senior surveyor and institutional training with III/NIA **should start after the results of the III exam** for the specific department.
4. During practical training with a surveyor, the trainee should have maintained proper records of training.
5. The documents required for registration for the final practical test. Soft copy of the Documents sent to on **surveyor\_training@iii.org.in**

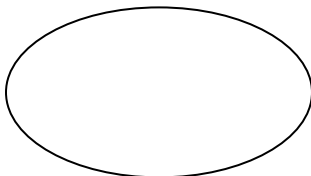
