

Institutional Practical Training for Additional departments

As per the guidelines issued by the IRDAI, an Institutional Practical Training for **Additional departments** shall be conducted by the Insurance Institute of India (III) for **Marine Cargo, Fire, Motor, Miscellaneous, Engineering, Loss of Profit, Marine Hull and Crop insurance departments**. Eligibility for enrolment requires candidates to have passed the relevant examination conducted by the Insurance Institute of India for the respective subject.

The training module consists of two parts:

Part I of the training will be conducted on **digital platform (MS Teams)** for **1 week (6 days)** in **each additional department** with Introduction to different type of policies, terms, conditions, warranties, coverage's, add-on-covers, various terminologies used in insurance, and nature of claims, use of technology, various techniques and tools for assessment of risk and losses. Report writing, including presentation of facts, admissibility of the claims in a precise and accurate manner and importance of timely submission of reports in compliance with regulatory requirements; Code of conduct required for treating policy holders fairly during the entire process of assessment of loss. Use of public domain for relevant information.

Part II of the training module consists of onsite training for **1 week (6 days)** to be taken on their own by participants under the guidance of a senior surveyor, **having 8 years of experience in the concerned department**; in accordance with IRDAI guidelines after completing one week of practical training with the Insurance Institute of India.

There will be a **Final Practical Test** conducted at the end of the above training module, which is mandatory for all participants.

Who can enrol: Existing Surveyors who passed the additional papers for departments other than those holding a license under the new scheme as per Circular No. IRDA/SURGDL/MISC/068/03/2021.

Certificate: Certificate will be issued after completion of the training and passing the Final Practical Test.

Eligibility criteria:

1. Enrolment with IRDAI for the department should not be **older than 3 years**.
2. Candidate should have passed mandatory **S-01 (Principles and Practice of Insurance and Survey and Loss Assessment)** and at **his respective subject** exam conducted by III **before commencement** of the practical training with senior surveyor **for the respective subject**.
3. The candidate should be a **licence holder**
