

INSTITUTIONAL PRE LICENSING PRACTICAL TRAINING FOR FRESH SURVEYORS FOR THE YEAR 2023

Insurance Institute of India is conducting Pre licensing training for fresh surveyors as per IRDAI circular IRDA/SUR/GDL/MISC/068/03/2021 dated 01st April 2021. The training will commence from 20th September 2023. The candidates will have to undergo 2 months of training at College of Insurance, Insurance Institute of India. Out of this 2 months, 5 weeks of training will be conducted on digital platform (MS Teams) and part of 3 weeks will be onsite training under the guidance of any surveyor who has at least 8 years' experience in the concerned department as per guidelines issued by IRDAI.

During this training, the candidates will be equipped with knowledge of all branches of insurance along with soft skills. This specific course is designed taking into considerations the practical aspects of syllabus, so that candidates are able to quickly adapt to rigor of carrying out quality surveys and report writing.

Who can enroll?

Those candidates who must have passed the compulsory subject S-01 and the relevant subject for which License is sought. For e.g. if the candidate wants to enroll for Motor and Crop Insurance then he should have passed paper S-01-Principles and practice of General Insurance and Insurance Survey and Loss assessment and also papers S-06 (Motor Insurance) and S-09 (Crop Insurance) respectively.

Candidate can enroll for maximum 3 subjects at a time.

Duration of the training:

Onsite Training	Week - 3	-	Under the guidance of an experienced surveyor as per IRDAI guidelines.
Final Practical Test	The date and time for the final practical test will be intimated after the conclusion of onsite training.		

Important Notice:

- 1. On completion of online training and practical onsite training, an online Final Practical Test will be conducted by the Insurance Institute of India, the date of which will be announced in due course.
- 2. Course Fees to be paid- Rs.59,000/- (Rs.50,000/- + 18% GST) per participant.
- **3.** The Candidates undergoing the online training with Insurance Institute of India need not pay any additional fees for the Final Practical Test.
- **4.** The candidates will have to identify a senior surveyor on their own, with whom they would undertake the 3 Weeks practical onsite training. Moreover, the location of the candidate and the location of the surveyor should be in the same city or not farther than 200 km (or they have to take approval from IRDAI for training beyond prescribed km.) The cost for practical onsite training to be imparted by Surveyors/IIISLA has to be incurred separately by the participants.

- **6.** After registration we will share the schedule of the training with participants in detail.
- 7. Documents required to be submitted before commencement of Online Training:
 - a) IRDAI Enrolment Number
 - b) III Qualifying Exam Passing Certificate
 - c) Passport Size Photo (maximum 10 kb)
- **8.** Candidates who have opted for Non institutional training for 6 months with the experienced surveyors would be allowed to take the Final Practical Test at a nominal fee of Rs.2500/-
 - + 18% GST (per subject) along with those undergoing 8 weeks of Institutional training conducted by Insurance Institute of India. The dates for these exam would be announced on our website in due course.
