# Institutional Pre Licensing Practical Online Training For Fresh License Surveyors

Insurance Institute of India is conducting Pre licensing training for fresh surveyors as per IRDAI circular IRDA/SUR/GDL/MISC/068/03/2021 dated 01st April 2021. The training will commence from **28th July 2025.** The candidates will have to undergo 8 Weeks of training at College of Insurance, Insurance Institute of India. Out of this 8 Weeks, **5 weeks of training will be conducted on digital platform (MS Teams) and part of 3 weeks will be onsite training** under the guidance of any insurance surveyor and loss assessor who has at least 8 years' experience in the concerned department.

The five-week online training programs cover understanding of domain subjects along with Introduction to Surveyor's regulations, Duties and responsibilities, Report wiring and Soft skills. This specific course is designed taking into considerations the practical aspects of syllabus, so that candidates are able to quickly adapt to rigor of carrying out quality surveys and report writing.

### Who can enroll?

Those candidates who must have passed the compulsory subject S-01 and the relevant subject for which License is sought. For e.g. if the candidate wants to enroll for Motor and Crop Insurance then he should have passed paper S-01-Principles and practice of General Insurance and Insurance Survey and Loss assessment and also papers S-06 (Motor Insurance) and S-09 (Crop Insurance) respectively. **Candidate can enroll for maximum 3 subjects at a time.** 

## Documents required to be submitted before commencement of Online Training:

- a) IRDAI Enrolment Number Enrolment with IRDAI for the department should not be older than 3 years.
- b) III Registration No.
- c) III Mark sheet copy
- d) IIISLA Registration Number, if available
- e) Passport Size Photo (maximum 10 kb)
