Insurance Institute of India is announcing Pre licensing final practical test for Fresh surveyors and Existing surveyors for Additional Dept. The Final Practical Examination is proposed on **02nd September 2026 and 03rd September 2026 on the Microsoft Teams platform.**

Eligibility criteria for Final Practical test:

1. Enrolment with IRDAI for the department **should not be older than 3 years.**
2. Practical training with a senior surveyor and institutional training with III/NIA should start after the results of the III exam for the specific department.
3. Candidate should have passed mandatory **S-01 (Principles and Practice of Insurance and Survey and Loss Assessment)** and at **his respective subject** exam conducted by III **before commencement** of the practical training with senior surveyor **for the respective subject.**
4. During practical training with surveyor, trainee should have maintained proper records of training.

5. Passport Size Photo **in jpg image** (maximum 10 kb)

Training completed with senior surveyor – 2 months training

1. III Marksheet
2. Licence Copy
3. **Training completion certificate- 2 months**
Manual training completion certificate on Surveyor's Official letterhead (TCC format given by IRDAI) duly signed and stamped. If training is taken with corporate surveyor's Director or employee, then the trainer should have essentially an individual SLA and TCC would be on his own letterhead with stamp.
4. Quarterly reports generated for **2 months.**
5. IIISLA Membership Certificate (if available)
6. Passport Size Photo **in jpg image** (maximum 10 kb)
