Before the paper enrollment date:

Prepare the time-table and take the approval from officer.

2) Send mail to IT department to upload the same time table on our web portal Path is Examination >>Surveyors Exam>>Surveyors Online exam schedule



- 3) On same day, the department (oficer) send mail to IRDAI the Session wise exam timetable of Surveyors examination before start the enrollment. (Mail has to be sent to kiransharma@irdai.gov.in or Pankaj Tiwari informing them about the exam date, time etc. We have to ask them to provide the eligible Surveyor list of candidates).
- 4) Once the list is received from IRDAI, we have save in Q:

- 5) The list received from IRDA is changed to III Excel format and saved and upload on III portal.
 - A) The excel format is as below:






B} Upload the excel sheet on below mentioned path:




C) Select the file and then click on upload




D) After upload the list, download the uploaded list to check the total uploaded data (i.e. no. of candidates)










- 6) After upload the list on portal, send mails regarding paper enrollment to the eligible surveyors and also inform to the IRDAI through the mail (Once the paper enrollment closed, we have not accepted any list from IRDAI)
- 7) If any candidate calls to find out whether his name has been enrolled or not, we have to use the same path for checking, please go to the below given path:



- 8) If candidate has any query regarding Surveyors examination, i.e. regarding syllabus, enrollment, examination fees, dates etc. he/she has to visit our website www.insurancesnstituteofindia.com as well as to visit IRDAI's website www.irda.gov.in

1) If any candidate forgot to book the slot then III book the slot manually: (same as mentioned the professional exam)




- 1) After the result is declared officially, the following documents along with the letter sent to IRDAI(through mail and hard copy)




